

WROUGHTON ASC - MEMBERSHIP NOTICE 2017

Classes of Membership:

1. Under 18's and those in full time education:

Membership + Swimming Fees on Club Nights (and mornings where applicable) - £250

2. Senior Swimmers Membership + Swimming Fees to be agreed with Membership Secretary on an individual basis.
3. Committee & Poolside Helpers - all helpers MUST be members for insurance purposes - £5
4. An additional £10 will be added to new memberships to cover the cost of a club hat and drawstring bag.

5. Sunday evening training is by invitation and is covered under a separate notice.

6. **A membership application form must be completed each year by both new members and those renewing their membership.**

Payment of Fees:

1. Payment of fees can either be made by cheque (payable to Wroughton ASC) or by internet transfer direct to the Club's Bank Account.
2. Whilst payment in full is preferred, we appreciate this can be difficult for some, so staged payments for full membership can be accepted as follows;

1 st Payment - 28 February.	£110 (£10 covers hat and bag)	£100
2 nd Payment - 31 March.	£75	£75
3 rd Payment - 30 April.	£75	£75

3. New members who join after 31 March are expected to pay the full agreed fee in one instalment following the 2 week trial.

General Conditions:

1. The Fees for each year are due in full on the 1st January each year and must be paid by 28 February unless paying in instalments.
2. The fees for the current year have been determined by the Club Annual General Meeting, following recommendations made by the Club Committee.
3. All fees due, must be paid, or arrangements for payment agreed by the Membership Secretary, by the end of February in each year. Failure to comply with clause 1, may result in automatic termination of membership.
4. In the event of non -payment by the due date, the insurance for that member will cease and as a result, the individual will not be able to participate in any of the Club's activities, including training.
5. Each member, or their parent / guardian (in the event of the swimmer being under 18) must complete in full, the Membership Application Form each year – including details of any medical details or learning difficulties that may be relevant, and sign the declarations required.
6. Membership is at the sole discretion of the Committee
7. Those joining the Club in the middle of the year, need to confirm the fees payable with the Membership Secretary.
